

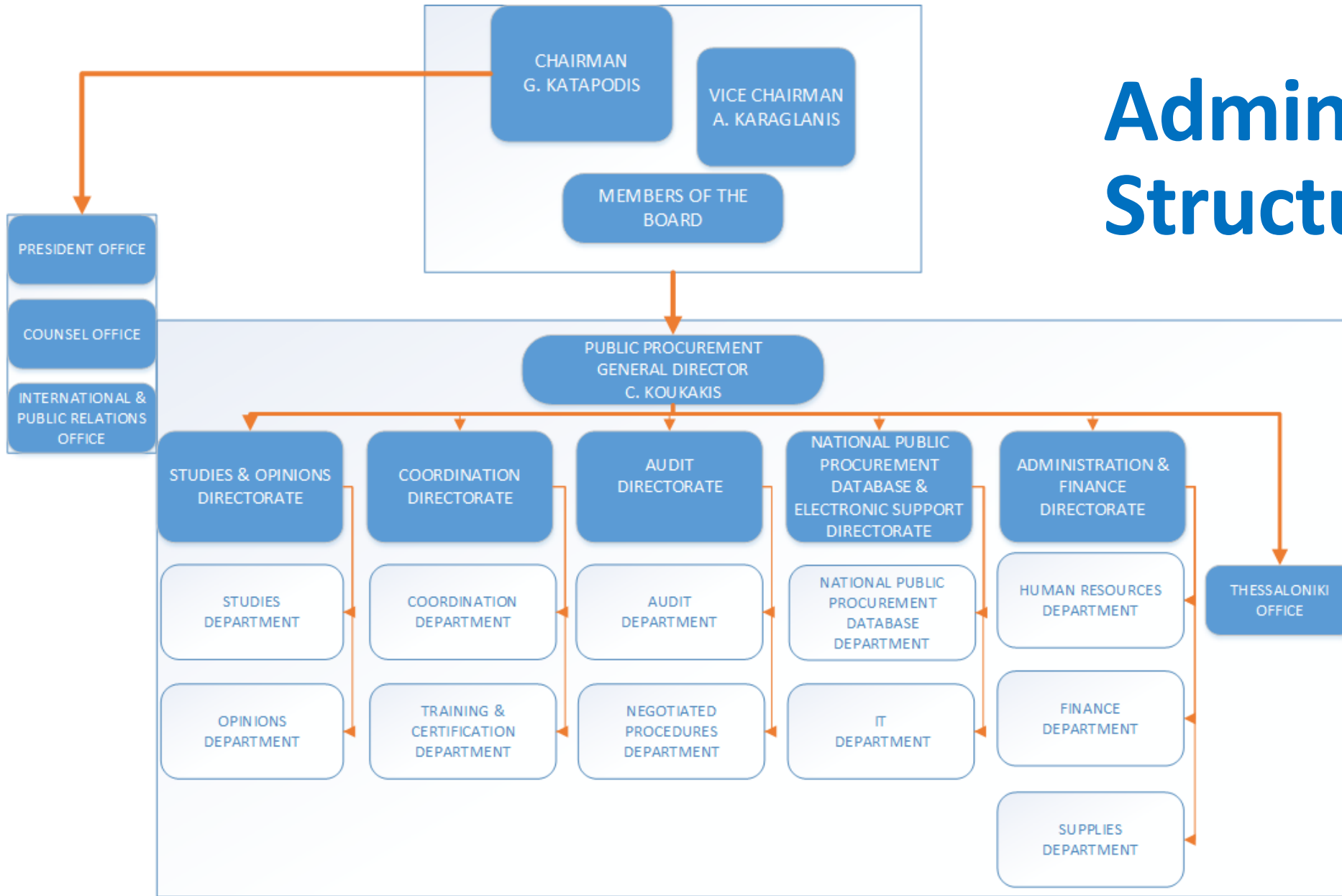

HSPPA Role & Responsibilities



Administrative Structure



Transposition EU 2014/23, 24, 25 DIR

- ✓ Dir 24, 25 transposition → L. 4412/2016 (8-8-2016)
- ✓ Dir 23 transposition → L. 4413/2016 (8-8-2016)

PP L. 4412/2016

- ✓ **Transposition** of Dir 2014/24 & 2014/25 rules + national rules
- ✓ **Consolidation, simplification & streamlining** of procurement procedures
- ✓ **Reform of the review and remedy system**

Consolidation

- ❖ The PP.L regulates **all FORMS of procurement** conducted by **any TYPE CA/CE**
- ❖ **Common rules for contracts above / below threshold** with minor deviations for low budget contracts
- ❖ **Uniform review rules** – establishment of an independent review body
- ❖ HSPPA is the national body that monitors the application of Dir. 24 & 25 rules, provide information and guidance on the interpretation and application of the Union PP law and operates as the interlocutor with the Commission services on public procurement

Simplification & streamlining

- ❖ Advertisement through a single electronic system
- ❖ Complete adoption of e-procurement (for procurement above 60.000 EUR)
- ❖ Consolidation of bid opening and tender evaluation
- ❖ Issuance of standard tender documents by HSPPA

HSPPA - Streamlining PP Procedures

Issuance of standard documents

- ✓ Self Declaration Standard Document (equivalent to ESPD for low value contracts)
- ✓ Participation Guarantee Letter
- ✓ Performance Guarantee Letter

Issuance of Standard Tender Documents for

- ✓ Work contracts
- ✓ Design contracts
- ✓ Supply contracts
- ✓ Services contracts
- ✓ Framework Agreements for supplies
- ✓ Dynamic Purchasing System for pupils transportation

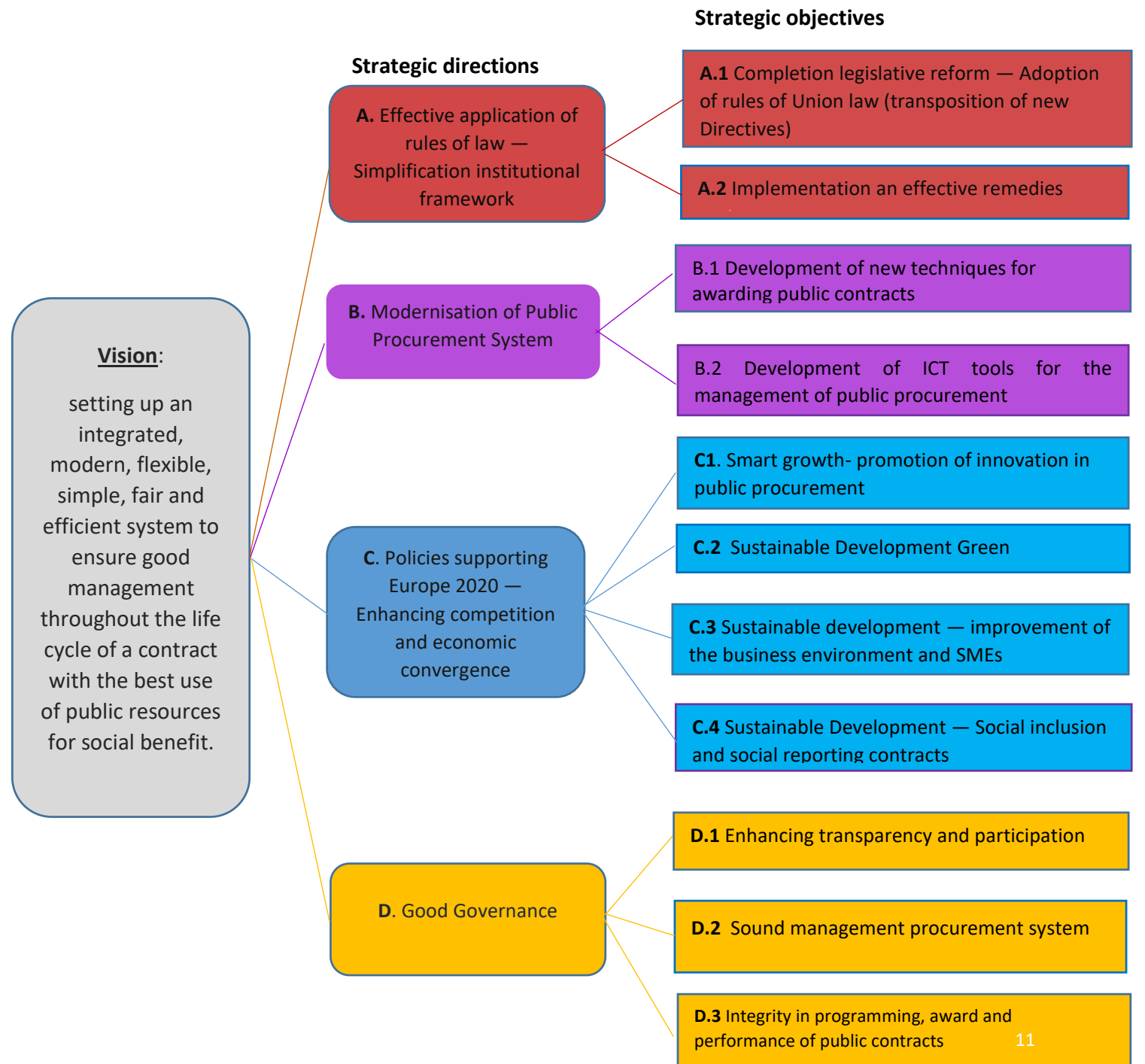
Issuance of Guidelines on

- ✓ Exclusion grounds
- ✓ Selection criteria
- ✓ Adapting (for CAs) and filling in (for EOs) ESPD / SDSD
- ✓ Award criteria
- ✓ Subcontracting
- ✓ Reliance on the capacities of other entities
- ✓ Modification of contracts
- ✓ Competitive dialogue
- ✓ Contracts below the thresholds
- ✓ Avoiding common errors in PP

L. 4413/2016

- ✓ Integration of Dir 2014/23 + national rules
- ✓ Common rules for contracts above / below threshold with minor deviations for under threshold contracts
- ✓ Adoption of a basic legal framework enabling conditions and terms to be specified in contract documents
- ✓ HSPPA is the national body that monitors the application of Dir. 23 rules, provide information and guidance on the interpretation and application of the concession legal framework and operates as the interlocutor with the Commission services on concessions procurement

E-PROCUREMENT INFORMATION SYSTEMS:

- ✓ **MONITORING TOOL FOR PUBLIC PROCUREMENT:** National Public Procurement Database (NPPDB)
- ✓ **E-PROCUREMENT PLATFORM:** National Electronic Public Procurement System (NEPPS – “ESIDIS”)
- ✓ **E-TRANSPARENCY PLATFORM:** Central Electronic Registry for Public Procurement (CERPP – “KIMDIS”)
- ✓ **ESPD PLATFORM:** National ESPD service

National Database for Public Procurement (NPPDB) - overview

- ✓ Collection of data from public sector's databases (European and National court decisions for public procurement, KIMDIS)
- ✓ Monitoring the data uploaded in CERP ("KIMDIS") for statistical and audit reasons.
- ✓ Purposes:
 - Single point of information for public procurement in a "data driven" economy.
 - A valid and reliable system for open governance in the field.
 - A key element of the monitoring and oversight mechanism in the field.

- ✓ Production mode, from June of 2018
- ✓ Public access
